- B. Lawn Jockeys to do bush trimming and removal of bushes for \$1500.0 for entire association. Motion made by Denny to approve, 2nd by Mary, board unanimously approved. (Additional items added at June 25th special meeting).
- C. New Age, plant old glory maple (6508 Barton) and Japanese silk lilac tree (6532 Cheslie) @ 285.00 per tree, includes planting to be done as soon as possible no later than three weeks. Bush replacement for 54 bushes @1,863.00. Topsoil and sod for unit 6529 Barton, includes trucking and labor \$1,535.00. Barb made motion to approve, Ted 2nd, board unanimously approved, after much discussion of planting state street maple tree at 6508 Barton, as recommended by arborist, last year. (tree at 6508 Barton amended June 25th special meeting) D. Freedom Masonry repair brick on garage at base (6505 Manton) \$350.00. Motion made by Mary to approve, Barb 2nd, board approved unanimously
- E. Iowa Concrete Solutions concrete repairs

F. Parking Lot Specialties were selected for the following services: Restriping, for \$200.00, Random cracks with ¼" diamond blade router. Clean out crack with high pressure dry compressed air then apply single component hot pour sealant - \$573.75. Denny made motion to approve, 2nd by Mary, unanimously approved by board.

Services will wait until concrete done.

G. Iowa Concrete Leveling -8815 Hanworth - raise one panel to reduce edge, due to adjoining panel being replaced - no more than \$500.00. Denny made motion to approve, 2^{nd} by Mary, unanimously approved by board.
